



Juvenile Justice Fund CEASE Intern (Summer 2011)

The mission of the Juvenile Justice Fund (JJF) is to fulfill the unmet needs of children and families coming through Georgia's juvenile justice system. We partner with the Fulton County Juvenile Court to address those needs by advocating at the federal, state and local level; implementing direct service programs; providing education and training; and increasing public awareness. All children always matter is the driving force behind all of our programs, which are specifically focused on stopping the commercial sexual exploitation of children (CSEC) and supporting family reunification efforts.

Our internship program is designed to give undergraduate and graduate students the opportunity to actively participate in the work we do to protect and serve the children who need us most. Although interns will work within a specific program or department, our hope is that they will understand the totality of JJF and will be able to work from a framework that encompasses the entire organization. In addition to providing essential programmatic assistance to JJF staff, interns will gain an understanding of critical issues for youth in metropolitan Atlanta, learn more about the way a non-profit organization operates, obtain valuable skills they can take into the workforce upon graduation and participate in networking opportunities with JJF staff and juvenile court employees.

CEASE (Center to End Adolescent Sexual Exploitation) provides prevention and early intervention services for girls coming through the juvenile justice system, many of whom have experienced some form of child abuse. CEASE recently created the Voices Project to work with girls ages 11-17 to empower them and provide opportunities to strengthen and reinforce the program's chief principle, "Yesterday I found my voice, Today I'm here to shout about it!" In order to deter adolescents from early victimization and address key areas widely known to put girls in danger of CSEC, all aspects of the Voices Project will deliver the fundamental messages necessary to educate clients about CSEC dangers and promote healthy relationships and self-esteem. The CEASE Intern will work directly with the Voices Project Coordinator to implement all aspects of the Voices Project.

CEASE Intern Responsibilities:

- Contact clients on a regular basis
- Plan weekly activities for clients
- Create brochures and flyers
- Prepare for and assist with weekly sessions for the Voices Project clients
- Provide administrative support for Voices Project Coordinator
